LET US HAVE A LOOK ON THE MEDICAL STANDARDS

1. The candidate must be in good physical and mental health and free from any disease/disability which is likely to interfere with the efficient performance of duties
2. There should be no evidence of weak constitution, bodily defects or over weight.
3. The minimum acceptable height for Male candidate is 157.5 cms. For women candidate's minimum acceptable height is 152 cms. For Gorkhas and individuals belonging to hills of North Eastern region of India, Garhwali and Kumaon, the Minimum acceptable height will be 5 cms less. In case of candidates from Lakshadweep, the minimum acceptable height can be reduced by 2 cms for males and females candidates.
4. Chest should be healthy. For males the minimum range of expansion after full inspiration should be 5 cms. In recording the measurements, fraction of less than 0.5 cm will be ignored, 0.5 cm will be recorded as such and 0.6 cm and above will be recorded as 1 cm. X-Ray of the chest is compulsory and will be taken to rule out any disease of the chest.
5. There should be no disease of bones and joints of the body.
6. A candidate should have no past history of mental breakdown or fits.
7. The hearing should be normal. A candidate should be able to hear a forced whisper with each ear at a distance of 610 cms. in a quiet room. There should be no evidence of present or past disease of the ear, nose and throat.
8. There should be no sign of functional or organic disease of the heart and blood vessel. Blood pressure should be normal.
9. The muscles of abdomen should be well developed and there should be no enlargement of liver or spleen. Any evidence of disease of internal organs of the abdomen will be a cause for rejection.
10. Un-operated hernias will make a candidate unfit. If operated, this should have been done at least 1 year prior to the present examination and healing is completed.
11. There should be no hydrocele, varicocele or piles.
12. Urine examination will be done and any abnormality, if detected will be a cause for rejection.
13. Any disease of the skin which is likely to cause disability or disfigurement will also be a cause for rejection.
14. A candidate should be able to read 6/6 in a distant vision chart with each eye with or without glasses. Myopia should not be more than 3.5D and hypermetropia not more than 3.5D including Astigmatism. For women candidates the minimum acceptable visual acuity are: Distant vision (corrected) better eye 6/6 worse 6/18, Myopia of not more than minus 5.5 including Astogination.
15. Internal examination of the eye will be done by means of ophthalmoscope to rule out any disease of the eye. A candidate must have good binocular vision. The colour vision standard will be CP-III for Army A candidate should be able to recognize red and green colours.
16. Candidates who have undergone or have the evidence of having undergone Radial Keratotomy, to improve the visual acuity, will be permanently rejected.

DECLARATION BY THE APPLICANT/PARENT

I will clear all my dues regarding college fees, library, hostel & other matters before filling enrollment/examination form, otherwise I will not be allowed to fill University/Board examination form & my admission will be automatically get cancelled & I also agree that university/Board examination card will be issued to me by college only when I will produce No Dues certificate, otherwise I shall be responsible for being debarred from university/Board examinations.

I agree that if disqualified by University/Board/Concern Coordinator at any stage for enrollment/examinations, admission given to me shall be automatically cancelled & I will not hold the college responsible for this & will not demand any fee refund and till the confirmation of my admission by the concern coordinator/University/Board, my admission will be provisional.
8. I shall appear at all the sessional examinations/class tests/ midterm/internal exams and pre-university exams conducted by the College and shall secure minimum 48% marks in all the papers, failing which I shall have to appear at the Golden test and secure minimum 48% which I shall take as the last chance for being eligible to appear at the University examination. If I remain absent in the conditional/golden test or if I fail in these examinations, then college authorities have full right to debar me from appearing in the university/Board examination.
9. I have clearly read the information given in the college prospectus and I shall follow the same.
10. I agree that college has all the rights to terminate me from the college for any sort of in disciplinary activities **including ragging** & I will be responsible for this.
11. I shall follow all the rules and regulations instructed by the college authorities from time to time. Rules are subject to change from time to time for academic and operational purposes, I shall be governed by the latest rules & regulations come into force.
12. I will follow the latest rules and regulations of Shekhawati Defence College from time to time.

If my result of qualifying exam is not declared till the last date notified by the concerned Coordinator/Govt. of Rajasthan, admission given to me shall be automatically get cancelled & I shall not hold the college responsible for the same in that case fees deposited by me will be adjusted in next year fees in same course.
14. I will maintain minimum 75% attendance in all theory & practical papers separately.
